**RESOLUTION IN SUPPORT OF PENDING LEGISLATION TO
AMEND THE CONSTITUTION OF THE COMMONWEALTH
OF PENNSYLVANIA FOR LEGISLATIVE AND
CONGRESSIONAL REDISTRICTING PROCESSES**


WHEREAS, recent legislation has been introduced in the previous and current Pennsylvania legislative sessions to amend the Pennsylvania Constitution to reform the decennial legislative and congressional redistricting process with the intent of using fairness and sound methodology in a non-partisan fashion.

NOW, THEREFORE, BE IT RESOLVED that the Lower Macungie Township Board of Commissioners does hereby support legislative efforts to secure expeditious action to make a constitutional amendment that would, among other reforms, assign the decennial task of both legislative and congressional redistricting to an independent citizens redistricting commission; and

BE IT FURTHER RESOLVED that a copy of this resolution be delivered to all members of the Pennsylvania Senate and House of Representatives.
